Description of the qualification

The programme is a Level 6 Diploma for art therapists qualified to master's or equivalent level. Overseas applicants with a suitable equivalent qualification in art therapy are welcome to apply.

This intensive theory-informed and practice-based programme aims to equip learners with the knowledge and skills required to provide effective, inspiring, ethical, and art-based supervision to supervisees from arts therapies and related professions (arts in health, counselling, psychotherapy, etc).

Art-based processes in supervision will feature prominently in the curriculum, which will also cover artmaking techniques and activities for use within supervision. Participants will also be required to create a visual journal as part of their learning process. Understanding the implications of the legal framework as well as organisational dynamics and their impact on supervision will be an integral part of the programme. The training will also focus on enabling participants to become research-aware supervisors and to learn how to evaluate the efficacy of their supervisory work.



Training requirements

- **Taught seminars:** real-time attendance for online teaching days is essential. All full-time and part-time learners attend monthly one-day online seminars (full days on Wednesdays, approximately once per month) for one year. Part-time learners then spend the following year completing other programme elements.
- **Supervisory practice:** supervising two to three art therapists over at least six months, or a combination of groups and individual supervision. Part-time learners will undertake their supervisory work in the 2nd year of the programme.
- **Supervision of supervisory practice:** individual one-hour monthly supervision (in the 2nd year for part-time learners) will be provided.

Written requirements

- **Essay:** critiquing models of supervision (3500 4000 words).
- **Evaluation of supervision practice:** recording, transcribing, and analysing ten-minute excerpts of two supervision sessions with your tutor-supervisor (2000 words).
- Final Case Study: including excerpts from transcription above (7000 to 8000 words).



Additional requirements

- Pre-seminar engagement with relevant articles and other learning resources.
- Keeping a visual journal.
- Regular supervision-tutorials ('supervision on supervision') with an allocated tutorsupervisor.
- Attendance at a one-hour mid-programme assessment meeting with your tutor-supervisor and programme leader.
- Attendance at three academic tutorials for support with assessed elements of the programme.
- A spoken 'viva' assessment towards the end of the programme, which includes spoken presentations of your case study and visual journal.

Learning Objectives

The programme addresses seven overarching learning objectives, which are described in detail in the programme handbook (the handbook will be accessible to participants who register on the training):

- 1. Work safely, legally, procedurally, and ethically as an art therapy supervisor.
- 2. Model and supervise the use of an art therapy relationship.
- 3. Model and supervise understanding of diversity.
- 4. Model and supervise an art therapy approach to the supervisory work.
- 5. Model and supervise use of self in art therapy.
- 6. Model and supervise a coherent use of theory and skills.
- 7. Evaluate and supervise supervisory practice.

Assessment – what will be assessed and how

Learners will be required to submit an electronic portfolio to evidence their understanding of the seven core learning objectives. The portfolio will contain a 'learning log' clearly specifying where the supporting evidence can be found and how it relates to the core learning outcomes. Assessments will be undertaken by seminar leaders, tutor-supervisors, self, and peers.

To successfully achieve the qualification your portfolio must provide evidence of you using the seven learning outcomes in action. Essay submissions should evidence knowledge of models of supervision and critical thinking. Learning objectives need to be evidenced over the lifetime of



the whole programme.

You will be assessed through:

- A case study presentation evidencing all of the learning objectives.
- Records of supervisions-tutorials evidencing all of learning objectives.
- Records of participation in seminars evidencing all of learning objectives.
- Ongoing visual journal submission evidencing all of learning objectives.
- Transcribed supervision sessions, transcription, analysis and reflection

All learners will have a mid-programme assessment to review their progress in meeting the learning objectives and identify achievements and challenges. Final assessment will include a spoken viva assessment where learners will present a synopsis of their case study and reflections on their visual journal. Vivas will be held within three months post completion of the programme.

Teaching faculty

The programme leader holds overall responsibility for programme content and delivery. Additional relevantly experienced visiting presenters will deliver specific specialist teaching inputs. Learners will also be supported in monthly one-to-one supervision sessions by our team of tutor-supervisors.

Programme costs

We offer this programme with full-time and part-time options and fees are priced accordingly.

Frequently Asked Questions (FAQs)

How will the programme be delivered?

Monthly seminars will be delivered online via Zoom allowing all learners to access the programme regardless of their location. We have extensive experience in delivering popular and well received online training programmes that are creative and engaging for participants.

Will I be expected to find my own supervisees?

Yes, but if you are based in the UK we can try to help you if you are having difficulties finding supervisees. If you wish to continue with one of your current supervisees, this may be possible providing that you can introduce and implement programme processes within your supervision. However, you will need to ensure that you start at least one of the supervision contracts from the beginning whilst you are on the programme. This can be at your current place of work or as a self-employed supervisor.

Can I get paid for my supervision work while on the programme?

Yes, you can charge your usual supervisory rates, or a reduced rate if this is your first supervisory experience.

Will I be expected to find my own supervisor?

No. A tutor-supervisor will be allocated to you for the duration of the programme. They will be a suitably qualified and experienced art therapist who will be fully versed with the programme curriculum to enable you to maximise the application of learning to your work setting. Online



supervision sessions can be arranged at mutually convenient times for you and your supervisor.

Will I have to pay for my tutor-supervisor?

No. The cost of supervision is included in the programme fees.

Do I need to have a certain amount of experience of being a supervisor to apply? Although it will be helpful to have some experience of supervising, there is no minimum experience required for learners.

Will employers recognise this qualification?

Employers recognise the value of CPD endorsed by the British Association of Art Therapists, and CPCAB validates a number of highly respected programmes. This programme will serve as the equivalent of a quality kite mark for art therapy supervision.

Are there any financial benefits?

Yes. Learners will receive 20% discount on our CPD courses during their term as a learner. You will also be able to charge for your supervisory work, which will compensate for some of the programme costs.
